Street Commissioner Report

Village Street Commissioner Craig Burkman updated the Council with the following:

- 600 feet of new drain pipe was installed in the alley between 4th/5th Street, between Baltic Ave. & Champion Ave.
- Public Works employees Brandon Skewes & Kody Maki took the Water Certification Test on November 1st.
- Public Works employee Dave Swetich took the Wastewater Certification Test on November 2nd.
- Range Telecommunications installed some new parts for the water tank, and the Village was able to use an antenna from Adams Twp. The water tank seems to be communicating with these repairs.
- The Public Works Equipment is already for winter.
- Trying to get the lagoons discharged before winter.
- Sand & salt are all mixed and in the salt shed.

Village President Report:

Village President George Eakin updated the Council with the following:

- Met with Street Commissioner Craig Burkman & Ron Petrelius on 10/9 to look at some possible ditching near Ron's late father's place on 7 th street.
- Kristen did find out the current owner of the vacant Whealkate Lot.
- Dave & President Eakin drove around to take pictures of Ordinance Violations on Monday 10/23. There were 15 letters sent out, and had a few responses, most were positive.
- We have 3 purchasing policies for the finance committee to look over, and make a recommendation on creating a policy for the Village (We also need to put a paving spec bid together for Whealkate Estates).
- Would like the utilities committee to come up with an official water shut off policy.

- Another Annexation Agreement for the Dollar General was recently signed, the original one could not be found.
- Just drove by the fireworks storage area near the snowmobile trail.... It looks like a mud bug was there.
- The drainage ditch issue isn't complete yet, U.P. Engineering is recommending to EGLE the culverts stay in place. Waiting for their response
- Village Public Works did a fantastic job on the 4th/5th street alley culvert work.
- Discussed a request by Ron Petrelius for the Village to sell or assist with access to his property on 7th St. He would like to create a garage in the backyard, but would need access through the alley. No action was taken.

Clerk's Report

- OpusWeb was able to launch the new website prior to the Council Meeting.
- We received our Insurance check for the flagpole in the amount of \$16,025.00. Once our tax exempt form is in with the company that gave the estimate, the Village cost for the flagpole replacement will be \$500.00, which is our deductible. That cost is for removal of existing pole, new concrete/pole, and placement of the new pole. The quote we have is only good till this month.
- Our next Sewer Bond payment is coming up. The amount is for \$4,731.20, this will need to be added to the Agenda.
