# Village President Report:

Village President George Eakin updated the Council with the following:

- President Eakin reached out to Pat Greeley, he said George would be the person in charge of the ordinance enforcement/procedure, per each ordinance requirement.
- Did ask Craig to call Range Communications concerning the tank communication issue, he hasn't heard back from them yet.
- OHM won't need to assist any longer with the alley between 4 th & 5 th street, the guys will now replace the pipe, the problem was found with the help of the Township, they were a huge help with their new camera in locating the large tree roots that were plugging it up. OHM will still assist with the alley between 5th/6th streets.
- U.P. Engineering is still working on the "model" for EGLE concerning the drainage ditch.

- Kristen quickly located the zoning ordinance in an office file. She's now been here 2 years. We are lucky to have her, she's done an awesome job for our Village. She is quick to handle every & ANY request that is asked of her. President Eakin stated has been on the Council for over 10 years now, & NEVER has had as much information brought out to the meetings, he truly hopes everyone appreciates that.
- Talked with Ron Petrelius concerning the drainage ditch near his late father's home, and wants to meet to discuss dredging it out a bit.

# **Clerk's Report**

- Talked to Jeff from OpusWeb. Still need to get the Ordinances scanned in as individual PDF's, and send them to them to get them up. Then he will hand over the website and do training with me if needed.
- Received a call about Sleigh Rides within the Village. Someone has rented one with horses,
  for the end of December with an event at the Range Lounge. They were wondering if they
  could have Village or Township approval for what areas they could possibly do it in. Council
  would like to check with the Village Insurance about having horses.
- Quarterly taxes were completed.
- Received our yearly Insurance rates from the Hannula Agency. They stated the cost to build
  has gone up, therefore rates have with all our buildings. They suggested we look at some of
  our vehicles covered fully, and look at possible liability insurance for them if not in use.
  Council would like to look into other Insurance companies for quotes on rates before the
  renewal time next year.
